How to Get There



Traveling by Public Transport:

Located in the city centre of Melbourne, the conference venue (Melbourne Marriott Hotel) is easily accessible by public transport.

Nearby airport:

Melbourne Tullamarine Airport (MEL) – 13.6 miles.

Easily accessible using Melbourne Skybus shuttles to either Melbourne CBD Southern Cross Station (a 10-minute drive to the venue) or to Skybus Coach Terminal (and continue journey on Tram routes 30/35/86/96). Tickets are available to purchase online, or via the ticketing booths at either the airport or Southern Cross Station. Transportation services from the airport also include trains, taxis and private cars.

By Tram:

Melbourne Central Station (0.5 miles to the venue) – Tram routes 19, 57, 59

Parliament Station (0.3 miles to the venue) – Tram routes 35, 86, 96

By Bus:

Exhibition Station (110 meters to the venue) - Bus routes 250, 302. For bus timetable or further trip planning, please use Public Transport Victoria's Journey Planner.

By Taxi or Uber:

Taxi drop off and pick up point is at Melbourne Marriott Hotel, Corner Exhibition & Lonsdale Streets. You can obtain taxis by taxi phone – 13 22 27 or 131 008. Uber also works properly in Melbourne, you can use your account to transfer to the conference venue.

Traveling by Car:

Participants arriving by car are advised to use the hotel's parking space available. There are 1 complimentary electric car charging station. Valet parking fee is AUD 50 daily (parking fees are not included in the registration fee).
