## **ANNUAL GENERAL MEETING 2021 ("AGM")**

ELECTION SLATE FOR THE FOUR (4) CURRENT VACANCIES ON THE AUSTCHAM SHANGHAI BOARD OF DIRECTORS 2021-2023

Ten (10) nominations in good standing have been received and accepted by AustCham Shanghai for the four (4) current vacancies on the AustCham Shanghai Board for 2021-2023, falling due at the AGM.

The following eligible candidates have been ordered alphabetically by member company that they represent.

The Board is satisfied that the candidates meet the suitability criteria set out in Clause 5.6, Schedule B of the Members Charter.

A copy of the skill set matrix of the five current directors who are not seeking re-election, and are halfway through a two-year term, can be found on the hyperlink in the email sent to members on 28th May 2021 enclosing the AGM agenda and Election Slate. Prior to voting for candidates, the Board would recommend that members review this skill set matrix to get a better understanding of which skills are needed to complement the existing skill set of the Board and assist in fulfilling the roles and responsibilities as set out in the Board Charter.

Resolution number twelve to be put to the AGM is to increase the number of authorised directors under the Constitution of the Company to eleven. In the event that resolution number twelve is passed at the AGM, the nominee shareholder of AustCham Consulting Limited ("AustCham Hk Kg"), the Hong Kong parent company, will instruct the Board of AustCham Hk Kg to pass a shareholders resolution of AustCham Shanghai to amend the Constitution.

Upon completion of the change to the Constitution, the Board will exercise their power under Clause 9, Schedule B of the Members Charter to fill a Board vacancy. The individual chosen to fill this vacancy will be the candidate with the fifth highest number of votes received from voting members in the election for vacancies on the AustCham Shanghai Board of Directors 2021-2023. Their appointment will be for an interim period until the holding of the AGM in 2022 at which point they may stand for re-election.
