All parties also acknowledge that the AustCham Shanghai Board of Directors shall make a recommendation to the membership as to those candidates it believes are suitable to join the Board, based on the suitability criteria provided in the addendum to the Call for Nominations.

Candidates are required to provide on this Nomination Form, or separately attached if wished, no more than 300 descriptive words for publication to clearly outline the contribution they believe they will contribute to the Board upon election. In addition, candidates are to provide full clear details of their preferred form of name(s), titles, professional role title(s), employing company name, email address and nationality. This will assist the Voting Member Representatives during the voting process.

The following documents must be submitted with this Nomination Form. Incomplete applications will not be accepted as valid.

- A fully completed nomination form with all required signatures. All signatures must be on the same form (this form).
- 2) A professional curriculum vitae updated to the time of submission, including reasonable detail, qualifications and work experience, language(s) and interests outside of work.
- 3) A colour portrait style photo an electronic copy of 1 x good resolution clear headshot to use in promoting you as a candidate.
- 4) A copy of the front page of the candidate's passport. If the candidate is not a Chinese citizen, copies of his/her current PRC work visa and work permit are also required.
- 5) A completed Candidate Skills Self-Assessment (page 3 of the N06 document, from the Call for Nominations email).



Nomination of each candidate standing for election at the 2023 AGM must be received by email, addressed to the **Company Secretary, via** maria.mcdermott@austchamshanghai.com or delivered and received by hand at the AustCham Shanghai office (details below). **Nominations may only be made on this Nomination Form,** appropriately signed and filled out in inked writing.

Nominations close <u>promptly</u> at 5:00pm (China Standard Time) on Friday 21st April 2023. Full applications past this time will not be accepted.

It is the responsibility of those registering the nomination of a candidate for election to confirm that the nomination has been received and recorded, particularly if the time of sending the nomination is nearing the close of nominations. This shall be strictly enforced, without exception. Please check promptly if you have not received confirmation of receipt of your nomination from the Company Secretary at any time.

The Nominations Committee reserves the right to request further information regarding any nomination. It will meet with all candidates prior to the formal election notice being issued and shall endeavour to work with all candidates to schedule appropriate appointment times.
